2. Removal of the existing timber external doors and replacing with powder coated double glazed extruded aluminium with associated ironmongery and door access controls.
3. Replacement of rotten and significantly degraded timber weatherboarding adjacent to the replacement external windows and doors and redecoration.
4. Removal of mechanical and electrical items to facilitate the works and refixing on completion.
5. Building work in connection with the replacement windows and doors to include removal and reinstatement of the existing soffits and fascia??s to facilitate the works.
